APRIL 8, 2014 MEETING

GENERAL: MR NOEL MILLS ATTENDED THE MEETING TO ASK FOR REPAIRS TO BE DONE ON LEISURE ROAD. TRUSTEE JOE CHIURCO EXPLAINED THAT WE WERE WAITING ON BETTER WEATHER ALSO FOR THE PATCHING MATERIAL TO BECOME AVAILABLE. TRUSTEE ED CLARK TOLD BOARD THAT WE WERE WAITING FOR RATES FROM THE TUSCARAWAS COUNTY ENGINEERS FOR PATCHING MACHINE OIL. TRUSTEE ED CLARK TOLD BOARD THAT THE ROAD LEVELER WAS RAN ON LEISURE, MAGNET, LEE LARDON, LARK AND MALWAYNE ACRES AND THAT THE DITCHING HEAD WOULD BE INSTALLED AND READY THIS WEEK.
