#### August 4, 2014 Meeting

**GENERAL:** MS. DIANE MYERS AND MR. ROBERT MCDONALD ATTENDED THE MEETING TO ASK ABOUT CHIPPING AND SEALING LEOPARD ROAD. TRUSTEES EXPLAINED THAT THE TOWNSHIP WAS LIMITED TO FUNDS AND ONLY ABLE TO MAKE REPAIRS. TRUSTEES TOLD THEM THAT THEY WOULD HAVE THE ROAD DEPARTMENT GO AND MAKE REPAIRS SOON. TRUSTEES WENT ON TO EXPLAIN TO THEM THAT THE TOWNSHIP WAS PUTTING ON A ROAD LEVY IN NOVEMBER. THE TRUSTEES EXPLAINED THAT IT COST THE TOWNSHIP TO PUT ON A LEVY AND ENCOURAGED THE RESIDENTS TO SUPPORT THE ROAD LEVY.

BOARD DISCUSSED AND AGREED TO FURNISH ROY WALLACE THE TEMPORARY FULL-TIME PERSON WITH UNIFORMS AND ALSO HOSPITALIZATION REIMBURSEMENT. JOE CHIURCO AGREED TO MAKE SURE MR. WALLACE BRINGS IN THE PROPER DOCUMENTATION TO GET REIMBURSED.

TRUSTEES DISCUSSED THE REPAIRS NEEDED ON LEGEND & LILLY ROADS. TRUSTEE ED CLARK INFORMED, BOARD THAT MAGNET ROAD CHIP AND SEAL WAS COMPLETE.

TRUSTEE JOE CHIURCO TOLD THAT REPAIRS HAD TO BE MADE ON THE BACK-HOE DUE TO STORM DAMAGE BUT WERE COMPLETE. HE ALSO TOLD OF REPAIRS TO THE MOWER.
