GENERAL: TRUSTEES DISCUSSED THE TOWNSHIP COMPLAINTS RECEIVED SINCE OUR LAST MEETING. BOARD AGREED TO HAVE ROAD WORKERS CONTINUE ON ROAD REPAIRS AS WEATHER AND FINANCES PERMITS.

BOARD WAS INFORMED OF THE ANNUAL FISH DINNER ON AUGUST 15, 2013 AT FOX TOWNSHIP.

MR JOHN JONES OF MALWAYNE ACRES ATTENDED WITH A COMPLAINT ABOUT THE DUST FROM THE LIMESTONE THAT WAS PUT INTO THE POT HOLES. MR JONES FELT THAT IT WAS NECESSARY TO HAVE THE DUST CONTROLLED. TRUSTEE JOE CHIURCO EXPLAINED THAT WITH THE HIGHER COST OF ROAD MATERIAL AND SURCHARGES THE TOWNSHIP COULD NOT AFFORD TO PUT ASPHALT OR EVEN TAR WITH LIMESTONE. MR CHIURCO ENCOURAGED MR JONES THAT IF HE WOULD GET THE OTHER RESIDENTS TO AGREE TO PAY FOR THE COST OF DUST CONTROL, HE WOULD BE GLAD TO CHECK INTO THE PRICE.
