GENERAL: AT 6:30 P.M. MEETING BEGAN WITH THE APPROVAL OF THE 2013 BUDGET, NO ONE ATTENDED THE BUDGET HEARING. CHAIRMAN ROD WISE MADE MOTION TO ACCEPT THE FOLLOWING BUDGET FOR BROWN TOWNSHIP FOR 2013. SECONDED BY TRUSTEE ED CLARK BOARD ALL IN AGREEMENT.
