BOARD OF BROWN TOWNSHIP TRUSTEES MET ON TUESDAY SEPTEMBER 4, 2012 AT 6:30 PM DUE TO THE LABOR DAY HOLIDAY.

TRUSTEES DISCUSSED COMPLAINTS ABOUT THE SPEED LIMIT ON LILLY ROAD, MOTION WAS MADE BY TRUSTEE ED CLARK, SECONDED BY TRUSTEE JOE CHIURCO TO HAVE THE STATE OF OHIO DO A SPEED STUDY FOR THE TOWNSHIP FOR LILLY ROAD.

BOARD DISCUSSED THE LEMON ROAD UPGRADE, THIS UPGRADE WAS COMPLETED WITHOUT ANY TOWNSHIP TAX DOLLARS, THE TOTAL PROJECT WAS 100% FUNDED BY CHESAPEAKE OIL & GAS EXPLORATION.
